LEVEL 1 TRAINING DAY

TRAINER SELECTION AND TRAINING MECHANISM:

ROUTE 1: Consultants, Associate Specialists and Named or Designated Nurses Eligibility

It is important that you only complete this process if you are eligible according to the following criteria:

- Consultant or Associate Specialist with experience in child protection work OR
- Named or Designated Nurse

You also need to have completed a Generic Instructor Course (GIC) or equivalent. If you have attended an equivalent course you should send the course programme to the Child Protection (CP) Facilitation course centre when you apply for a place on the course.

If you have not attended either the GIC or an equivalent course then you should be able to demonstrate via your CV that you have experience of one-to-one teaching and/or undergraduate teaching (particularly PBL). Your CV should be sent to the centre when you apply for a place on the course if this is your route to achieving eligibility.

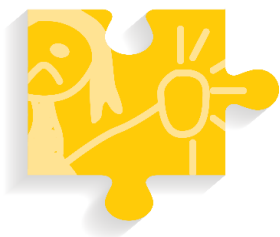
Anyone who embarks on the process who is not eligible will not be allowed to teach on courses and any costs incurred in completing the process will not be reimbursed.

Process

If you are eligible then you will need to observe a CPRR course and inform ALSG that you have completed this by submitting the form on the 'Instruct on a Course' page on the ALSG website. You can then apply for a CP Facilitation Trainer course (see programme below). The course fee for attending the CP Facilitation Trainer course should be covered by the individual trainers CPD funds.

When you have completed the CP Facilitation Trainer course you will then be shadowed and assessed when you teach on the first two CPRR courses.

Trainers should teach on 3 courses and complete the Part A (VLE component) every 2 years, to retain their trainer status.
