Honorary Clinical Data Analyst with MCAI

The Scottish (North-West Highland-based), international medical charity Maternal & Childhealth Advocacy International (known as MCAI) is looking for an experienced data analyst to help MCAI on a long-term basis with our important Monitoring and Evaluation work for our life-saving programs in Liberia, West Africa. This work will involve uploading, accurately recording, analysing, and reporting data from the following:

- --Trainee/ intern/ qualified: obstetric/ neonatal/ paediatric clinician logbooks
- --Obstetric outreach visits and follow up (in 4 Counties)
- --Maternal fetal monitoring (currently in 4 Hospitals)
- --Neonatal Resuscitation at Basic Emergency Obstetric and Neonatal Clinics (BEmONCs-18 clinics)
- --Pain control in Labour (using IV paracetamol- currently in 2 hospitals)

With the possibility of the additional of further projects.

Specifics

- This role can be done virtually from home.
- This role will be on a long-term basis, at least a year in the first instance with a view to further extension.
- This role will be initially on a voluntary basis as an "Honorary" Clinical Data Analyst, but MCAI will provide an "Honorarium" of £200/ net month (on which MCAI will pay tax). (However, if MCAI can secure funding and depending on work performance, there is the potential for this role to become a part-time salaried position.)
- The role of Honorary Clinical Data Analyst will require at least a minimum of 4 hours per week with a maximum of 12 (these hours will change if this position becomes a part-time salaried position).
- MCAI will provide virtual training, supervision, and support for this work.
- It is expected that the individual will use their own computer.
- There will be a "Letter of Agreement" between the individual who is appointed as Honorary Clinical Data Analyst and MCAI instead of a work contract.

Requirements for this role Essential



- Highly experienced in using computers, especially excel, Word, and other data management soft-ware packages
- Highly Experienced in data management platforms and different databases, including setting up a database if necessary.
- Experienced in shared platforms such as the "Cloud" and the G-Drive
- Dedicated individual who perceives this work as "vocational" and understands the lifesaving nature of MCAI's work.
- Individual who pays great attention to detail

Desirable

A clinical/ healthcare-based background would be highly beneficial.
